A request to rezone property from CH/RS-1 (Commercial-Heavy/Residential Single-Family) to MN-1 (Mixed-Use Neighborhood) located generally west of East Pinhook Road, east of S. General Marshall Street, and south of Clifford Street.

A request to rezone property from A/RS-1 (Agricultural/Residential Single-Family) to CM-1 (Commercial-Mixed) located generally south of Camellia Boulevard, east of Kaliste Saloom Road, and west of Bluebird Drive.
